This ADDENDUM TO CLASS ACTION AND PAGA SETTLEMENT AGREEMENT modifies the CLASS ACTION AND PAGA SETTLEMENT AGREEMENT fully executed by Plaintiff JASON PEAVICH and Defendant LANGAN ENGINEERING AND ENVIRONMENTAL SERVICES, LLC f.k.a. LANGAN ENGINEERING AND ENVIRONMENTAL SERVICES, INC. on June 25, 2024. The below sections of the CLASS ACTION AND PAGA SETTLEMENT AGREEMENT have been modified to state the following.

ARTICLE I

DEFINITIONS

e. <u>Class Counsel</u>. "Class Counsel" shall mean Arrash T. Fattahi and Arman A. Salehi of Wilshire Law Firm.

pp. <u>Settled PAGA Claims</u>. "Settled PAGA Claims" means all claims for PAGA penalties during the PAGA Period based on the facts and theories asserted in the PAGA Notice, including, but not limited to, alleged failure to pay for all hours worked, including minimum, straight time and overtime wages, failure to provide meal periods, failure to authorize and permit rest periods, failure to pay all earned wages twice per month, failure to maintain accurate records of hours worked and meal periods, failure to timely pay all wages at termination, failure to furnish accurate wage statements, failure to indemnify for necessary expenditures, and violations of California Labor Code §§ 201, 202, 203, 204, 226, 226.3, 226.7, 510, 1174, 1194, 1198, 2802, and Industrial Welfare Commission Wage Orders.

d. Named Plaintiff and Defendant attended mediation with Monique Ngo-Bonnici on March 22, 2024, after which the Parties reached the Agreement through acceptance of a Mediator's Proposal. The Parties agree that the terms and conditions of this Agreement are the result of lengthy, intensive arms-length negotiations between the Parties supervised by an experienced employment law mediator. The Parties agree that the Agreement is entered into in good faith as to each Class Member, and the State of California on behalf of the PAGA Members, and that the Settlement is fair,
