**AMENDMENT TO THE JOINT
STIPULATION OF CLASS ACTION AND
PAGA SETTLEMENT**

1 This Amendment to the Joint Stipulation of Class Action and PAGA Settlement is
2 entered into by Plaintiff Summer Huber (“Plaintiff”) on her own behalf and on behalf of all
3 members of the Class on the one hand and Defendant Evolve Dental Technologies, Inc.
4 (“Defendant”) on the other.

5 **RECITALS**

6 1. On June 25, 2024, the Parties fully executed the Joint Stipulation of Class
7 Action and PAGA Settlement (“Settlement Agreement”) representing the long-form agreement
8 submitted to the Court for approval.

9 2. On July 12, 2024, Plaintiff submitted the Settlement Agreement to the Court for
10 approval, which was set for hearing on November 8, 2024.

11 3. On November 6, 2024, the Court issued a tentative ruling ordering the Parties to
12 modify portions of the Settlement Agreement (and exhibits), as well as provide supplemental
13 information for the Court’s review, and continued the Preliminary Approval Hearing to March
14 14, 2025.

15 4. Thereafter, the Parties met and conferred and agreed to modify certain portions
16 of the Settlement Agreement (and exhibits) consistent with the Court’s order and hereby submit
17 this Amendment to the Joint Stipulation of Class Action and PAGA Settlement.

18 **STIPULATION**

19 **1. Section I(E) previously read as follows:**

20 **Class:** All current and former hourly-paid or non-exempt employees of Defendant
21 within the State of California at any time during the period from October 9, 2019 through
22 August 6, 2024 or the date of preliminary approval, whichever date is earlier. Defendant
23 estimates there are approximately 45 Class Members who worked 4,391 workweeks during the
24 Class Period.

Section I(E) shall now read as follows:

Class: All current and former hourly-paid or non-exempt employees of Defendant within the State of California at any time during the period from October 9, 2019 through August 6, 2024. Defendant estimates there are approximately 45 Class Members who worked 4,391 workweeks during the Class Period.

2. Section I(J) previously read as follows:

Class Period: The time period from October 9, 2019 through August 6, 2024 or the date of preliminary approval, whichever date is earlier.

Section I(J) shall now read as follows:

Class Period: The time period from October 9, 2019 through August 6, 2024.

3. Section I(S) previously read as follows:

Eligible Aggrieved Employees: The allegedly aggrieved employees eligible to recover settlement funds from the PAGA Payment consist of all current and former hourly-paid or non-exempt employees of Defendant within the State of California at any time during the period from October 9, 2022 through August 6, 2024 or the date of preliminary approval, whichever date is earlier. Defendant estimates there are approximately 26 Eligible Aggrieved Employees who worked 874 pay periods during the PAGA Period.

Section I(S) shall now read as follows:

Eligible Aggrieved Employees: The allegedly aggrieved employees eligible to recover settlement funds from the PAGA Payment consist of all current and former hourly-paid or non-exempt employees of Defendant within the State of California at any time during the period from October 9, 2022 through August 6, 2024. Defendant estimates there are approximately 26 Eligible Aggrieved Employees who worked 874 pay periods during the PAGA Period.

4. Section I(CC) previously read as follows:

PAGA Period: The time period from October 9, 2022 through August 6, 2024 or the date of preliminary approval, whichever date is earlier.

Section I(CC) shall now read as follows:

PAGA Period: The time period from October 9, 2022 through August 6, 2024.

5. Section III(G)(2) previously read as follows:

Tax Withholdings. Participating Class Members' Individual Settlement Shares will be apportioned twenty percent (20%) as wages and eighty percent (80%) as penalties and interest. The employees' share of payroll tax withholdings and other legally required withholdings shall be withheld from the portion of the Individual Settlement Shares attributed to wages. The amounts paid as wages shall be subject to all tax withholdings made from an employee's wages and all other authorized and required withholdings and shall be reported by IRS Form W-2. The amounts paid as penalties and interest shall be subject to all authorized and required withholdings other than the tax withholdings made from employees' wages and shall be reported by IRS Form 1099. Eligible Aggrieved Employees' portion of the PAGA Payment will be allocated as one hundred percent (100%) penalties and shall be reported by IRS Form 1099.

Section III(G)(2) shall now read as follows:

Tax Withholdings. Participating Class Members' Individual Settlement Shares will be apportioned thirty-three and one-third percent (33.33%) as wages and sixty-six and two-third percent (66.67%) as penalties and interest. The employees' share of payroll tax withholdings and other legally required withholdings shall be withheld from the portion of the Individual Settlement Shares attributed to wages. The amounts paid as wages shall be subject to all tax withholdings made from an employee's wages and all other authorized and required withholdings and shall be reported by IRS Form W-2. The amounts paid as penalties and interest shall be subject to all authorized and required withholdings other than the tax withholdings made from employees' wages and shall be reported by IRS Form 1099. Eligible Aggrieved Employees' portion of the PAGA Payment will be allocated as one hundred percent (100%) penalties and shall be reported by IRS Form 1099.




