### SETTLEMENT AGREEMENT AND RELEASE OF CLASS ACTION

2 This Settlement Agreement and Release of Class Action ("Settlement Agreement") is made and 3 entered into by: (1) Plaintiff Samuel Dardompre ("Plaintiff"), individually and in his representative 4 capacity on behalf of the Settlement Class, as defined below, and as a private attorney general on behalf 5 of the State of California; and (2) Defendant SDG Enterprises ("Defendant"). Plaintiff and Defendant are collectively referred to herein as the "Parties." This Settlement Agreement is subject to the approval 6 7 of the Court, pursuant to California Rules of Court, rule 3.769, subdivisions (c), (d), and (e), and is 8 made for the sole purpose of attempting to consummate settlement of the action on a class-wide basis 9 subject to the following terms and conditions. As detailed below, if the Court does not enter an order 10 granting final approval of this Settlement Agreement or the conditions precedent are not met for any 11 reason, this Settlement Agreement is void and of no force or effect whatsoever.

12 1. **DEFINITIONS** 

As used in this Settlement Agreement, the following terms shall have the meanings specified below. To the extent terms or phrases used in this Settlement Agreement are not specifically defined below, but are defined elsewhere in this Settlement Agreement, they are incorporated by reference into this definition section.

# 1.1. ACTION

"Action" shall mean the following civil action: *Samuel Daldompre v. SDG Enterprises*, case
number CIVSB2312325, currently pending before the Superior Court of the State of California for the
County of San Bernardino.

# **1.2. ADMINISTRATIVE EXPENSES**

22 "Administrative Expenses" shall include all costs and expenses associated with and paid to the
23 third-party settlement administrator, which are estimated not to exceed \$30,000.00.

#### **1.3. APPLICABLE WAGE ORDER**

25 "Applicable Wage Order" shall mean the California Industrial Welfare Commission ("IWC")
26 Wage Order applicable to the facts of this case, including IWC Wage Order 16-2001 and others that
27 may be applicable. (Cal. Code of Regs., tit. 8, § 11160.)

**CLAIMS**

2 "Claims" shall mean the claims asserted in the Action. 3 1.5. **CLASS ATTORNEY FEES AND EXPENSES** 4 "Class Attorney Fees and Expenses" shall mean the portion of the Gross Settlement Amount 5 attributable to attorney fees and litigation expenses. The Parties agree that the fee-portion of the Class Attorney Fees and Expenses shall be up to one-third of the Gross Settlement Amount (i.e., 6 7 \$223,322.00), as approved by the Court, and the award of costs and expenses shall be up to an 8 additional \$25,000.00. If the Escalator Provision described below is triggered so as to increase the 9 Gross Settlement Amount, the Parties agree that the fee portion of the Class Attorney Fees and 10 Expenses will increase proportionally such that the total amount of attorneys' fees remains one-third 11 of the Gross Settlement Amount after the upward adjustment required by the Escalator Provision is 12 implemented. **CLASS COUNSEL** 13 1.6. 14 "Class Counsel" shall mean Jonathan Melmed, Laura Supanich, and Maria Burciaga of Melmed 15 Law Group P.C. 1.7. **CLASS MEMBER** 16 17 "Class Member" shall mean any person who is a prospective member of the Settlement Class, 18 or, if such person is incompetent or deceased, the person's legal guardian, executor, heir, or successor-19 in-interest. 20 1.8. **CLASS NOTICE** "Class Notice" shall mean the Notice of Proposed Class Action Settlement, as set forth in the 21 22 form of Exhibit 1 attached hereto, or as otherwise approved by the Court, which is to be mailed to 23 Class Members along with the Share Form. 1.9. **CLASS PARTICIPANTS** 24 25 "Class Participants" shall mean all Class Members who do not timely request exclusion from the Class Settlement. 26 27 1.10. CLASS PERIOD

28 "Class Period" shall mean the period from September 2, 2020, through October 24, 2024.

17	Settlement Agreement has been executed by all Parties and by Class Counsel and Defense Counsel;	
18	(b) the Court has given preliminary approval to the Class Settlement; (c) notice has been given to the	
19	Settlement Class providing them with an opportunity to request exclusion from the Class Settlement;	
20	(d) the Court has held a Final Approval and Fairness Hearing and entered a final order and judgment	
21	certifying the Settlement Class and approving this Settlement Agreement; and (e) the later of the	
22	following events: (i) the expiration of the period for filing any appeal, writ, or other appellate	
23	proceeding opposing the Class Settlement has elapsed without any appeal, writ, or other appellate	
24	proceeding having been filed; (ii) the dismissal of any appeal, writ, or other appellate proceeding	
25	opposing the Class Settlement with no right to pursue further remedies or relief; or (iii) any appeal,	
26	writ, or the issuance of such other final appellate order upholding the Court's final order with no right	
27	to pursue further remedies or relief. In this regard, it is the intention of the Parties that the Class	
28	Settlement shall not become effective until the Court's order approving the Class Settlement is	

completely final and there is no further recourse by an appellant or objector who seeks to contest the
 Class Settlement. If no objections are filed, the Effective Date shall be after steps (a) through (d) are
 completed (i.e., the date that the court has entered a final order and judgment certifying the Settlement
 Class and approving this Settlement Agreement).

### 1.18. EMPLOYEE'S TAXES AND REQUIRED WITHHOLDING

6 "Employee's Taxes and Required Withholding" shall mean the employee's share of any and all
7 applicable federal, state, or local payroll taxes, including those collected under authority of the Federal
8 Insurance Contributions Act (FICA), the Federal Unemployment Tax Act (FUTA), and/or the State
9 Unemployment Tax Act (SUTA) on the portion of any Class Participant's Individual Settlement
10 Amount that constitutes wages. The Employee's Taxes and Required Withholdings will be withheld
11 from and paid out of the Individual Settlement Amounts paid from the Net Settlement Amount.

# **1.19. EMPLOYER'S TAXES**

"Employer's Taxes" shall mean and refer to Defendant's share of payroll taxes (e.g.,
Unemployment Insurance, Employment Training Tax, Social Security, and Medicare taxes) that is
owed on the portion of any Class Participant's Individual Settlement Amount that constitutes wages.
The Employer's Taxes shall be separately paid by Defendant and shall not be paid from the Gross
Settlement Amount or Net Settlement Amount.

# 1.20. FINAL APPROVAL AND FAIRNESS HEARING

19 "Final Approval and Fairness Hearing" shall mean the final hearing held to ascertain the20 fairness, reasonableness, and adequacy of the Class Settlement.

# **1.21. GROSS SETTLEMENT AMOUNT**

"Gross Settlement Amount" is the agreed upon non-reversionary settlement amount totaling \$669,966.00 to be paid by Defendant in full settlement of the Released Claims asserted in this case, inclusive of the Administrative Expenses, the Employee's Taxes and Required Withholdings, the Class Attorney Fees and Expenses, the Incentive Award, and PAGA Payment. Defendant shall separately pay its share of the Employer's Taxes in addition to the Gross Settlement Amount on the portion of each Individual Settlement Amount allocated as wages.

1 **HEARING ON PRELIMINARY APPROVAL** 1.22. 2 "Hearing on Preliminary Approval" shall mean the hearing held on the motion for preliminary 3 approval of the Class Settlement. 4 **1.23. INCENTIVE AWARD** 5 "Incentive Award" shall mean any additional monetary payment provided to the Class Representative for his efforts and risks on behalf of the Settlement Class in this Action. 6 **1.24. INDIVIDUAL SETTLEMENT AMOUNT** 7 8 "Individual Settlement Amount" shall mean the amount which is ultimately distributed to each 9 Class Participant, less any Employee's Taxes and Required Withholdings. The Individual Settlement 10 Amount does not include any portion of the PAGA Payment. 11 **1.25. NET SETTLEMENT AMOUNT** 12 "Net Settlement Amount" shall mean the Gross Settlement Amount minus: Administrative Expenses; Class Attorney Fees and Expenses; 75% of the share of the Gross Settlement Amount 13 allocated toward penalties pursuant to the Labor Code Private Attorney General Act of 2004 14 15 ("PAGA"), codified at Labor Code sections 2698 through 2699.6, which are payable to the California Labor and Workforce Development Agency ("LWDA"); and Plaintiff's Incentive Award. 16 1.26. OPT OUT 17 18 "Opt Out" shall refer to the process of submitting a timely and valid request for exclusion from 19 the Class Settlement in accordance with the terms of the Class Notice and no later than the Response 20 Deadline. **OPT-OUTS** 21 1.27. 22 "Opt-Outs" shall mean all persons who timely and validly request exclusion from the Class 23 Settlement in accordance with the terms of the Class Notice and no later than the Response Deadline. 24 **1.28. PAGA PAYMENT** 25 "PAGA Payment" means the penalties pursuant to PAGA that the Parties have agreed is a 26 reasonable sum to be paid in settlement of the PAGA claims included in the Action, which is 27 \$50,000.00. The PAGA Payment is to be approved by the Court pursuant to Labor Code section 2699 and is to be distributed as follows: seventy-five percent (75%) (i.e., \$37,500.00) to the LWDA and 28

1 twenty-five percent (25%) (i.e., \$12,500.00) to the PAGA Settlement Class. Class Counsel shall give 2 timely notice of this Settlement Agreement to the LWDA pursuant to Labor Code section 2699, 3 subdivision (1)(2). 1.29. PAGA PERIOD 4 5 "PAGA Period" shall mean the period from May 31, 2022, through October 24, 2024. 1.30. PAGA SETTLEMENT CLASS 6 7 "PAGA Settlement Class" shall mean all individuals who are or were employed by Defendants 8 as non-exempt employees in California during the PAGA Period. 9 1.31. PARTIES 10 "Parties" shall mean Plaintiff and Defendant. 11 **1.32. PLAINTIFF** 12 "Plaintiff" shall mean Plaintiff Samuel Daldompre. PRELIMINARY APPROVAL DATE 13 1.33. 14 "Preliminary Approval Date" shall mean the date upon which the Court enters an order 15 preliminarily approving this Settlement Agreement. 16 **1.34. RELEASED CLAIMS** 17 "Released Claims" shall mean those claims arising out of or related to the allegations set forth 18 in the operative complaint and/or PAGA notice to the California Labor and Workforce Development 19 Agency that arose during the Class Period and/or PAGA Period, including claims for: (1) failure to pay 20 minimum wage for all hours worked in violation of Labor Code sections 1194 and 1194.2, and the 21 applicable IWC Wage Order(s); (2) failure to pay proper overtime wages in violation of Labor Code 22 sections 510, 1197, and 1198, and the applicable IWC Wage Order(s); (3) failure to provide compliant 23 rest periods and pay missed rest break premiums in violation of Labor Code section 226.7 and the 24 applicable IWC Wage Order(s); (4) failure to provide compliant meal periods and pay missed meal

26 Order(s); (5) failure to maintain accurate employment records in violation of Labor Code section 1174;

period premiums in violation of Labor Code sections 226.7 and 512, and the applicable IWC Wage

27 (6) failure to pay timely wages during employment in violation of Labor Code sections 204, 210;

28 (7) failure to pay all wages due and owing at separation in violation of Labor Code sections 201, 202,

and 203; (8) failure to reimburse business expenses in violation of Labor Code sections 2802 and 2804;
(9) failure to provide complete and accurate wage statements in violation of Labor Code sections 226
and 226.3; (10) deceptive, fraudulent, or otherwise unlawful business practices based on the foregoing
in violation of California's Unfair Competition Law (Bus. & Prof. Code, §§ 17200–17210);
(11) statutory penalties based on the foregoing pursuant to PAGA (Lab. Code, §§ 2698-2699.6); and
(12) all claims for liquidated damages, penalties, interest, fees, costs based on the foregoing.

7 No other claims are released other than those claims specifically plead, or could have been 8 asserted based on the allegations, in the Complaint or otherwise specifically identified herein. This 9 Settlement Agreement will not release any person, party, or entity from claims, if any, by Class 10 Members for workers compensation, unemployment, or disability benefits of any nature. Nor does it 11 release any claims, actions, or causes of action which may be possessed by Class Members under state 12 or federal discrimination statutes, including, without limitation, the California Fair Employment and 13 Housing Act (Gov. Code, §§ 12900–12996); the Unruh Civil Rights Act (Civ. Code, § 51); the 14 California Constitution; Title VII of the Civil Rights Act of 1964 (42 U.S.C. § 2000, et seq.); the 15 Americans with Disabilities Act (42 U.S.C. § 12101, et seq.); the Employee Retirement Income Security Act of 1974 (29 U.S.C. § 1001 et seq.); and all of their implementing regulations and 16 interpretive guidelines. 17

#### **1.35. RELEASED PARTIES**

19 "Released Parties" shall mean Defendant and all of Defendant's past and present owners, 20 subsidiaries, affiliates, shareholders, members, officers, directors, managers, employees, attorneys, 21 agents, predecessors, successors, assigns, representatives, and any and all other persons, firms, 22 companies, corporations, and partnerships which may have an interest in Defendant or could be deemed 23 a joint employer with Defendant under the law.

24

#### **1.36. RELEASING PARTIES**

25 "Releasing Parties" shall mean every Class Participant and PAGA Settlement Class member 26 and all persons purporting to act on their behalf or purporting to assert a claim under or through them, 27 including, but not limited to, their dependents, heirs, assigns, beneficiaries, devisees, legatees, 28 executors, administrators, agents, trustees, conservators, guardians, personal representatives, and successors-in-interest, whether individual, class, representative, legal, equitable, direct or indirect, or
 any other type or in any other capacity.

3

# **1.37. RESPONSE DEADLINE**

4 "Response Deadline" shall mean the date sixty (60) days following the date on which the
5 Settlement Administrator first mails Class Notice to the Class Members and the last day on which Class
6 Members may submit a request for exclusion and/or objection to Class Settlement.

7

### **1.38. SETTLEMENT ADMINISTRATOR**

8 "Settlement Administrator" shall mean Apex Class Action Administration which the Parties
9 have agreed will be responsible for administration of the Class Settlement and related matters.

10

# **1.39. SETTLEMENT CLASS**

"Settlement Class" shall mean all individuals who are or were employed by Defendants as nonexempt employees in California during the Class Period. At mediation, Defendant represented that the
Settlement Class consists of approximately 453 Class Members that worked a total of approximately
38,887 workweeks during the period of September 2, 2020 to the date of mediation, September 24,
2024.

#### 1.40. SHARE FORM

"Share Form" shall mean the *Class Action Settlement Share Form*, as set forth in the form of **Exhibit 2** attached hereto, or as otherwise approved by the Court, which is to be mailed to Class
Members along with the Class Notice.

# 2. FACTUAL AND PROCEDURAL BACKGROUND

#### 2.1. PLAINTIFF'S CLAIMS

Plaintiff, individually and in his representative capacity on behalf of the Settlement Class, and as a private attorney general on behalf of the State of California, has alleged the following violations: (1) failure to pay minimum wage for all hours worked in violation of Labor Code sections 1194 and 1194.2, and the Applicable Wage Order; (2) failure to pay proper overtime wages in violation of Labor Code sections 510, 1197, and 1198, and the Applicable Wage Order; (3) failure to provide compliant rest periods and pay missed rest break premiums in violation of Labor Code section 226.7 and the Applicable Wage Order; (4) failure to provide compliant meal periods and pay missed meal period

1 premiums in violation of Labor Code sections 226.7 and 512, and the Applicable Wage Order; 2 (5) failure to maintain accurate employment records in violation of Labor Code section 1174; 3 (6) failure to pay timely wages during employment in violation of Labor Code sections 204, 210; 4 (7) failure to pay all wages due and owing at separation in violation of Labor Code sections 201, 202, 5 and 203; (8) failure to reimburse business expenses in violation of Labor Code sections 2802 and 2804; 6 (9) failure to provide complete and accurate wage statements in violation of Labor Code sections 226 7 and 226.3; (10) deceptive, fraudulent, or otherwise unlawful business practices based on the foregoing 8 in violation of California's Unfair Competition Law (Bus. & Prof. Code, §§ 17200-17210); and 9 (11) statutory penalties based on the foregoing pursuant to PAGA (Lab. Code, §§ 2698–2699.6).

10

#### 2.2. DISCOVERY, INVESTIGATION, RESEARCH, AND MEDIATION

11 Class Counsel has conducted significant informal discovery during the prosecution of the 12 Action. This discovery, investigation, and prosecution has included, among other things, (a) over a 13 dozen telephonic conferences with Plaintiff; (b) inspection and analysis of hundreds of pages of 14 documents and other information produced by Plaintiff and Defendant; (c) analysis of employment 15 data from a sample of Class Members; (d) an analysis of the legal positions taken by Defendant; 16 (d) investigation into the viability of class treatment of the claims asserted in the Action; (e) analysis of potential class-wide damages, including information sufficient to understand Defendant's potential 17 18 defenses to Plaintiff's claims; (f) research of the applicable law with respect to the claims asserted in 19 the Complaint and the potential defenses thereto; and (g) assembling and analyzing of data for 20 calculating damages.

Class Counsel and the Class Representative have vigorously prosecuted this case, and Defendant has vigorously contested it. The Parties have engaged in sufficient investigation and discovery to assess the relative merits of the claims of the Class Representative and of the defenses to them. After such discovery, investigation, and prosecution, the Parties attended a full-day mediation with an experienced employment law mediator, which culminated in a settlement in principle, the terms of which are elaborated in this Settlement Agreement.

# 2.3. ALLEGATIONS OF THE CLASS REPRESENTATIVE AND BENEFITS OF CLASS SETTLEMENT

The document and data exchange in this matter, as well as discussions between counsel, have been adequate to give the Class Representative and Class Counsel a sound understanding of the merits of their positions and to evaluate the value of the claims of the Settlement Class. The informal discovery conducted in this Action and the information exchanged by the Parties through pre-mediation discussions are sufficient to reliably assess the merits of the Parties' respective positions and to compromise the issues on a fair and equitable basis.

9 The Class Representative and Class Counsel believe that the claims, causes of action, 10 allegations, and contentions asserted in the Action have merit. However, the Class Representative and 11 Class Counsel recognize and acknowledge the expense and delay of continued lengthy proceedings 12 necessary to prosecute the Action against Defendant through trial and through appeals. Class Counsel has taken into account the uncertain outcome of the litigation, the risk of continued litigation in complex 13 14 actions such as this, as well as the difficulties and delays inherent in such litigation, and the potential 15 difficulty of obtaining certification of the Settlement Class as well as trying the claims of the class. Class Counsel is mindful of the potential problems of proof under, and possible defenses to, the claims 16 17 alleged in the Action.

The Class Representative and Class Counsel believe that the settlement set forth in this Settlement Agreement confers substantial benefits upon Plaintiff and the Settlement Class and that an independent review of this Settlement Agreement by the Court in the approval process will confirm this conclusion. Based on their own independent investigation and evaluation, Class Counsel has determined that the settlement set forth in this Settlement Agreement is in the best interests of Plaintiff and the Class Members.

#### 2.4. DEFENDANT'S DENIALS OF WRONGDOING AND LIABILITY

Defendant has denied and continues to deny all allegations, claims, and contentions alleged by Plaintiff in the Action. Defendant has expressly denied and continues to deny all charges of wrongdoing or liability against it arising out of any of the conduct, statements, acts, or omissions alleged in the

Action. Defendant contends that it complied with California and federal wage and hour laws and has
 dealt legally and fairly with Plaintiff and the Class Members.

3

Defendant further denies that, for any purpose other than settling this Action, these claims are 4 appropriate for class or representative treatment. Nonetheless, Defendant has concluded that further 5 proceedings in the Action would be protracted and expensive and that it is desirable that the Action be 6 fully and finally settled in the manner and upon the terms and conditions set forth in this Settlement 7 Agreement to dispose of burdensome and protracted litigation, to permit the operation of Defendant's 8 respective businesses without further expensive litigation and the distraction and diversion of their 9 personnel with respect to matters at issue in the Action. Defendant has also taken into account the 10 uncertainty and risks inherent in any litigation, especially in complex cases such as the Action. 11 Defendant has, therefore, determined that it is desirable and beneficial to it that the Action be settled 12 in the manner and upon the terms and conditions set forth in this Settlement Agreement.

13

# 2.5. INTENT OF THE CLASS SETTLEMENT

The Class Settlement set forth herein intends to achieve the following: (1) entry of an order approving the Class Settlement; (2) entry of judgment of the Action; (3) discharge of the Released Parties from liability for any and all of the Released Claims; and (4) discharge of Defendant from liability for any and all claims arising out of the Action.

# CONDITIONAL CERTIFICATION OF THE SETTLEMENT CLASS

19 For the purposes of this Settlement Agreement and the Class Settlement of this Action only, the 20 Parties agree to conditional class certification of the Settlement Class. Defense Counsel believes this 21 conditional certification is appropriate because the Released Claims are being compromised without 22 need to establish the elements of those claims on which liability turns. The certification of the 23 Settlement Class shall not constitute, in this or any other proceeding, an admission of any kind by 24 Defendant, including without limitation, that certification of a class for trial purposes is or would be 25 warranted, appropriate or proper; or that Plaintiff could establish any of the requisite elements for class treatment of any of the claims in the Action. 26

27 If the Settlement Agreement is not finally approved by the Court, the Effective Date is not
28 achieved, or the Class Settlement is rejected, terminated, or otherwise rendered null and void as set

forth herein, then certification of the Settlement Class shall be automatically vacated, shall be void *ab initio*, of no force or effect, and shall not constitute evidence or a binding determination that the
requirements for certification of a class for trial purposes in this Action or in any other action which
have been, are or can be, satisfied. Further, if the Agreement does not reach the Effective Date, Plaintiff
agrees that Plaintiff will not argue, claim, reference, or otherwise raise any preliminary approval of the
Settlement Class in connection with any later proceeding before the Court.

#### APPOINTMENT OF CLASS COUNSEL

8 For purposes of this Settlement Agreement and subject to the Court's approval, the Parties agree
9 to the appointment of Class Counsel as counsel for the Settlement Class and the effectuation of the

#### 5.1. SETTLEMENT AMOUNT

**CONSIDERATION** 

13 The Parties agree to settle this Action for the Gross Settlement Amount of \$669,966.00. There 14 shall be no reversion to Defendant. Defendant shall pay the Gross Settlement Amount in full. The Gross 15 Settlement Amount and other actions and forbearances taken by Defendant shall constitute adequate consideration for the Class Settlement and will be made in full and final settlement of: the Released 16 17 Claims, the Class Attorney Fees and Expenses, Administrative Expenses, the Incentive Award, the 18 PAGA Payment (and any payments to individual PAGA Class Members resulting from the PAGA 19 Payment), and any other obligation of Defendant under this Settlement Agreement (other than the 20 Employer's Taxes on the portion of the Net Settlement Amount allocated to the payment of wages).

After the Court issues an order preliminarily approving this Class Settlement, the Settlement Administrator will distribute the Class Notice to the Class Members, which shall describe the terms of the Class Settlement and procedures to Opt Out, object, or participate in the Class Settlement as well as the Share Form, which shall identify the Class Member, the number of workweeks worked by each Class Member ("Workweeks"), as well as the estimated amount of the Individual Settlement Amount the Class Member can expect to receive once the Class Settlement becomes effective on the Effective Date. Class Members shall be given the opportunity to challenge their Workweeks information.

#### 5.2. INCENTIVE AWARD FOR PLAINTIFF

2 Plaintiff may petition the Court to approve an Incentive Award in an amount up to \$7,500.00 3 for Samuel Daldompre to acknowledge his efforts on behalf of the Settlement Class in this Action, 4 including assisting in the investigation and consulting with Class Counsel and providing crucial 5 documents to Class Counsel. Defendant shall not oppose any request by Plaintiff for an Incentive 6 Award in such an amount. Any Incentive Award approved by the Court shall be paid to Plaintiff from 7 the Gross Settlement Amount and shall be in addition to any distribution to which he may otherwise 8 be entitled as a Class Participant. Any Incentive Award approved by the Court shall not be considered 9 wages, and the Settlement Administrator shall issue to Plaintiff an IRS Form 1099 reflecting such 10 payment. Plaintiff shall be responsible for the payment of all taxes with respect to any Incentive Award 11 approved by the Court and shall hold Defendant harmless from all liability with regard thereto.

#### 5.3. PAYMENT TO CLASS PARTICIPANTS

Each Class Participant shall be eligible to receive payment of the Individual Settlement Amount, which is a share of the Net Settlement Amount based on the pro rata number of weeks worked by the Class Members during the Class Period as a proportion of all weeks worked by all Class Members. Each Class Participant, including Plaintiff, shall be responsible for the payment of the Employee's Taxes and Required Withholding with respect to his or her Individual Settlement Amount and shall hold Defendant harmless from any and all liability with regard thereto.

19

#### 5.4. PAYMENT TO PAGA SETTLEMENT CLASS

20 Each member of the PAGA Settlement Class shall be entitled to receive a portion of the PAGA 21 Payment. The PAGA Payment shall consist of the penalties pursuant to PAGA that the Parties have 22 agreed is a reasonable sum to be paid in settlement of the PAGA claims included in the Action, which 23 is \$50,000.00. The PAGA Payment must be approved by the Court pursuant to Labor Code section 24 2699 and is to be distributed as follows: seventy-five percent (75%) (i.e., \$37,500.00) to the LWDA 25 and twenty-five percent (25%) (i.e., \$12,500.00) to the PAGA Settlement Class. The portion of the 26 PAGA Payment allocated to the PAGA Settlement Class shall be distributed to the PAGA Settlement Class based on the pro rata number of pay periods worked by each particular PAGA Settlement Class 27

member during the PAGA Period as a proportion of all pay periods worked by all members of the
 PAGA Settlement Class.

3

#### 5.5. TAX TREATMENT AND PAYMENT

4 For the purpose of calculating Employee's Taxes and Required Withholding for the Individual 5 Settlement Amounts for Class Participants (including any payments to the Class Representative but exclusive of his Incentive Award), the Parties agree that 20% of each Individual Settlement Amount 6 7 shall constitute payment in the form of wages (and each Class Participant will be issued an IRS Form 8 W-2 for such payment to him or her), and 80% of each Individual Settlement Amount shall constitute 9 penalties and interest (and each Class Participant will be issued an IRS Form 1099 for such payment 10 to him or her). Prior to final distribution, the Settlement Administrator shall calculate the total 11 Employee's Taxes and Required Withholding due as a result of the wage portion of Class Participants' 12 anticipated Individual Settlement Amounts and such actual amount will be deducted from the Net 13 Settlement Amount. Additionally, prior to the funding of the Gross Settlement Amount and final 14 distribution, the Settlement Administrator shall calculate the total Employer's Taxes due on the wage 15 portion of the Class Participants' Individual Settlement Amounts and issue instructions to Defendant to separately fund these tax obligations/withholdings. The Parties understand that Plaintiff and the 16 17 Class Participants who receive any payment pursuant to this Settlement Agreement shall be solely 18 responsible for all other individual tax obligations.

With respect to the PAGA Payment and any payments made to individual members of the PAGA Settlement Class, all such payments shall be treated as payments owing for penalties and interest thereon and shall not be considered wages. The Settlement Administrator shall issue to members of the PAGA Settlement Class an IRS Form 1099 reflecting such payment. Members of the PAGA Settlement Class shall be solely responsible for the payment of all taxes with respect to any PAGA payments made to them.

#### 5.6. NO EFFECT ON EMPLOYEE BENEFIT PLANS

Neither the Class Settlement nor any amounts paid under the Class Settlement will modify any
previously credited hours, days, or weeks of service under any employee benefit plan, policy or bonus
program sponsored by Defendant. Such amounts will not form the basis for additional contributions to,

1 benefits under, or any other monetary entitlement under Defendant's sponsored benefit plans, policies, 2 or bonus programs. The payments made under the terms of this Settlement Agreement shall not be 3 applied retroactively, currently, or on a going forward basis, as salary, earnings, wages, or any other 4 form of compensation for the purposes of any of Defendant's benefit plan, policy, or bonus program. 5 Defendant retains the right to modify the language of its benefits plans, policies, and bonus programs 6 to reflect this intent and to make clear that any amounts paid pursuant to this Settlement Agreement are 7 not for "weeks worked," "weeks paid," "weeks of service," or any similar measuring term as defined 8 by applicable plans, policies, and bonus programs for purpose of eligibility, vesting, benefit accrual, or 9 any other purpose, and that additional contributions or benefits are not required by this Settlement 10 Agreement. Defendant does not consider the Class Settlement payments "compensation" for purposes 11 of determining eligibility for, or benefit accrual within, any benefit plans, policies, or bonus programs, 12 or any other plan sponsored by Defendant.

13

#### 5.7. CLASS ATTORNEY FEES AND EXPENSES

As part of the motion for final approval of the Class Settlement, Class Counsel may apply for an award of Class Attorney Fees and Expenses with the fee portion not to exceed one-third of the Gross Settlement Amount (i.e., \$223,322.00) and the award of costs and expenses up to an additional \$25,000.00. Defendant agrees to not object to any such fee, cost, or expense application in those amounts.

As a condition of this Class Settlement, Class Counsel has agreed to pursue fees only in the manner reflected by this subsection. Any Class Attorney Fees and Expenses awarded by the Court shall be paid from the Gross Settlement Amount prior to arriving at the Net Settlement Amount and shall not constitute payment to any Class Members. If Class Counsel voluntarily reduces the request for Class Attorney Fees and Expenses or the Court's award of Class Attorney Fees and Expenses is less than set forth above, the Net Settlement Amount shall be recalculated to reflect the actual Class Attorney Fees and Expenses awarded.

The Class Attorney Fees and Expenses approved by the Court shall reflect: (a) all work performed and costs and expenses incurred by, or at the direction of, any attorney purporting to represent the Settlement Class through the date of this Settlement Agreement; (b) all work to be

performed and costs to be incurred in connection with approval by the Court of the Class Settlement;
 (c) all work to be performed and costs and expenses, if any, incurred in connection with administering
 the Class Settlement through the Effective Date and dismissal of the Action with prejudice; and (d) may
 be based on the "catalyst theory" and/or the "common fund doctrine."

# SETTLEMENT ADMINISTRATION

6

# 6.1. COSTS AND EXPENSES

All costs and expenses due to the Settlement Administrator in connection with its administration
of the Class Settlement, including, but not limited to, providing the Class Notice, locating Class
Members, processing Opt Out requests and objections, distributing the portion of the PAGA Payment
payable to the LWDA, distributing the portion of the PAGA Payment payable to the members of the
PAGA Settlement Class, and calculating, administering and distributing Individual Settlement
Amounts to the Class Participants and related tax forms, shall be paid from the Gross Settlement
Amount, and is not expected to exceed \$30,000.00.

# PAYMENT BY DEFENDANT

Defendant shall deposit the Gross Settlement Amount in a lump sum payment plus the employer-side payroll taxes to the Settlement Administrator within seven (7) days of the Effective Date. In no event shall Defendant be obligated to pay or deposit with the Settlement Administrator more than \$669,966.00 plus the Employer's Taxes, except where the Escalator Provision is triggered.

# NOTICE TO CLASS MEMBERS AND CLAIMS ADMINISTRATION PROCESS

# 7.1. THE SETTLEMENT ADMINISTRATOR

21 The Settlement Administrator will be responsible for: mailing the Class Notice and Share Form 22 (Exhibit 1 and Exhibit 2, respectively) to Class Members; posting notice of entry of final order and 23 judgment certifying the Class Settlement and approving this Settlement Agreement; handling inquiries 24 from Class Members concerning the Class Notice; determining Individual Settlement Amounts; 25 determining individual payments to members of the PAGA Settlement Class; maintaining the 26 settlement funds in an appropriate interest-bearing account; preparing, administrating, and distributing 27 Individual Settlement Amounts to Class Participants; preparing, administrating, and distributing 28 individual payments to members of the PAGA Settlement Class; distributing the portion of the PAGA Payment payable to the LWDA; issuing a final report and performing such other duties as the Parties
 may direct. Additionally, the Settlement Administrator will handle all tax document preparation and
 reporting, including state and federal tax forms, if any.

.

On a weekly basis, the Settlement Administrator will provide reports to Class Counsel and 4 5 Defense Counsel with summary information updating them as to the number of validated and timely objections and Opt Out requests. The Settlement Administrator will serve on Class Counsel and 6 7 Defense Counsel via e-mail date-stamped copies of the original Opt Out requests and objections no 8 later than seven (7) days after their receipt. The Settlement Administrator will provide Class Counsel 9 with proof of mailing of the Class Notice, without listing individual Class Member names which the 10 Settlement Administrator will file with the Court at the time Class Counsel files its motion in support 11 of the Court's Final Approval and Fairness Hearing.

No later than thirty (30) days prior to the Final Approval and Fairness Hearing, the Settlement
Administrator will compile and deliver to Class Counsel and Defense Counsel a report with summary
information regarding: (a) the total amount of final Individual Settlement Amounts of each Class
Participant, without any identifying personal information; (b) the number of Class Participants to
receive such payments, and (c) the final number of Opt-Outs and objections.

Administrative Expenses are not anticipated to exceed \$30,000.00. Prior to the calculation and distribution of the Individual Settlement Amounts, the Settlement Administrator shall calculate the total Administrative Expenses through the conclusion of their services and such actual amount will be deducted from the Gross Settlement Amount prior to the final calculation of the Individual Settlement Amounts.

#### 7.2. NOTICE TO CLASS MEMBERS

Notice shall be provided to Class Members in the following manner: Within fourteen (14) days
after the Preliminary Approval Date, Defendant shall provide the Settlement Administrator with an
updated list of Class Members and members of the PAGA Settlement Class containing names, social
security numbers, dates of employment, last-known addresses, and phone numbers (the "Database").
The Database shall be marked "Confidential – Settlement Administrator's Eyes Only." Class Counsel
shall not receive a copy of this list.

Within twenty-eight (28) days following the Preliminary Approval Date, the Settlement
 Administrator shall determine the number of workweeks worked by each Class Member, populate the
 data for each Class Member accordingly, and send each Class Member the Class Notice via first-class,
 United States mail. The Class Notice shall also contain an easily-understood statement alerting the
 Class Members that, unless they elect to Opt Out of the Class Settlement, the Class Member is releasing
 and waiving all Released Claims against the Released Parties.

7 The Class Notice will inform Class Members of their estimated share of the settlement and the 8 number of workweeks they worked during the Class Period. Class Members may dispute their 9 workweeks if they believe they worked more weeks in the Class Period than Defendant's records show 10 by submitting information to the Settlement Administrator no later than sixty (60) days after being 11 mailed the Class Notice and Share Form by the Settlement Administrator, which is the defined 12 Response Deadline. The Settlement Administrator will jointly work with Plaintiff and Defendant to 13 resolve the dispute in good faith. If Plaintiff and Defendant cannot agree over the workweeks to be 14 credited, the Settlement Administrator shall make the final decision based on the information presented 15 by the Class Member and Defendant.

16

#### 7.3. OPT OUT PROCEDURE

17 Class Members who do not timely Opt Out of the Class Settlement will be deemed to participate 18 in the Class Settlement and shall become Class Participants without having to submit a claim form or 19 take any other action. To Opt Out of the Class Settlement, the Class Member must submit a letter or 20 postcard to the Settlement Administrator by the Response Deadline. The Opt Out request must state 21 the Class Member's name, address, telephone number, and signature. The Opt Out request should state 22 something to the effect of:

Any Opt Out request that is not postmarked by the Response Deadline will be invalid. If prior to the Response Deadline any Class Notice mailed to a Class Member is returned as having been undelivered by the United States Postal Service, the Settlement Administrator shall perform a skip trace search and seek an address correction for such Class Members, and a second Class Notice will be sent to any new or different address obtained. Such Class Members shall have an additional fourteen (14) days from the date of the mailing of the second Class Notice in which to Opt Out, object, or dispute the information provided in the Share Form if the Response Deadline would have otherwise passed prior to fourteen (14) days from the date of the mailing of the second Class Notice.

It will be presumed that, if an envelope containing the Class Notice has not been returned within thirty (30) days of the mailing, the Class Member received the Class Notice. At least twenty-one (21) days prior to the Final Approval and Fairness Hearing, the Settlement Administrator shall provide Class Counsel and Defense Counsel with a Declaration of Due Diligence and Proof of Mailing with regard to the mailing of the Class Notice and its attempts to locate Class Members. The declaration shall specify the number of Class Members to whom the Class Notice was sent and the number of Class Members to whom the Class Notice was not delivered, as well as information relating to the number of Opt-Outs and objectors. Class Counsel shall file this declaration with the Court.

If the Settlement Administrator determines that an Opt Out request returned by a Class Member before the Response Deadline is deficient, then the Settlement Administrator shall mail a deficiency letter to that Class Member identifying the problem. If a Class Member submits both a dispute and an Opt Out request, the Settlement Administrator shall make reasonable attempts to clarify as if the Opt Out request were deficient. If the Class Member fails to cure the deficiency, the Opt Out request shall be disregarded and the claim will be paid, and the Class Member will become bound by the judgment.

Class Participants will be bound by the Release of Released Claims set forth in the definition of "Released Claims" provided in this Settlement Agreement.

A request to Opt Out of the Class Settlement shall *not* serve to exclude the Class Member from
 participation in the PAGA Settlement Class. Opt-Outs shall still be entitled to their share of the PAGA
 Payment. Class Members who are also members of the PAGA Settlement Class shall have no right or
 ability to opt out of the portion of this Settlement Agreement releasing PAGA claims.

5

### 7.4. OBJECTION PROCEDURE

The Class Notice shall inform the Class Members of their right to object to the Class Settlement 6 7 if they do not Opt Out. Any Class Participants who wish to object to the Class Settlement may submit 8 a written objection to the Settlement Administrator no later than the Response Deadline. Only Class 9 Participants may object to the Settlement. The objection should include the case name and number and 10 must set forth, in clear and concise terms, a statement of the reasons why the objector believes that the 11 Court should find that the proposed Class Settlement is not in the best interest of the Settlement Class 12 and the reasons why the Class Settlement should not be approved, including the legal and factual 13 arguments supporting the objection. If an objector also wishes to appear at the Final Approval and 14 Fairness Hearing, in person or through an attorney, they may do so. The Settlement Administrator will 15 promptly serve copies of any objection or notice of intention to appear on Class Counsel and Defense Counsel. Class Members wishing to make an objection may appear at the Final Approval and Fairness 16 17 Hearing, either in person or through a lawyer retained at their own expense.

# 7.5. NOTICE OF FINAL JUDGMENT

Within seven (7) days after the Court has held a Final and Fairness Approval Hearing and
entered a final order certifying the Class for settlement purposes only and approving the Class
Settlement, the Settlement Administrator will give notice of judgment to Class Members pursuant to
rule 3.771(b) of the California Rules of Court, by posting a copy of said order and final judgment on
its website at a web address to be included in the Class Notice.

# 8. <u>CLASS SETTLEMENT FUNDING AND DISTRIBUTION</u>

25

# 8.1. ALLOCATION OF THE GROSS SETTLEMENT AMOUNT

The claims of all Class Members are settled for the Gross Settlement Amount of \$669,966.00,
which will be allocated as follows:

28 1. The Administrative Expenses, estimated not to exceed \$30,000.00;

1 2. Class Counsel's attorney fees not to exceed \$223,322.00;

3. Class Counsel's litigation costs and expenses not to exceed \$25,000.00;

- 4. The Incentive Award, not to exceed \$7,500.00; and

5. PAGA Payment to LWDA of \$37,500.00.

For purposes of calculating the estimated Individual Settlement Amounts, the Settlement Administrator shall calculate the estimated Net Settlement Amount based on the estimated values provided above prior to sending Notice to the Class Members. Prior to final distribution, the Settlement Administrator shall recalculate the final Net Settlement Amount based on the actual values of the amounts in each category.

# 8.2. CALCULATION OF THE INDIVIDUAL SETTLEMENT AMOUNTS FOR CLASS PARTICIPANTS

Individual Settlement Amounts to be paid to Class Participants shall be paid from the Net Settlement Amount. The portion of the Net Settlement Amount shall be distributed pro rata on a "checks cashed" basis based on the proportional number of weeks worked by each Class Member during the Class Period.

16 Defendant will provide the Settlement Administrator with any information reasonably 17 necessary to perform the calculation of number of workweeks for each Class Member, and any other 18 reasonably required information the Settlement Administrator requests to perform the calculations 19 required under this Settlement Agreement. Defendant shall have no responsibility for deciding the 20 validity of the Individual Settlement Amounts or any other payments made pursuant to this Settlement 21 Agreement, shall have no involvement in or responsibility for the determination or payment of 22 Employee's Taxes and Required Withholding, and shall have no liability for any errors made with 23 respect to such Employee's Taxes and Required Withholding. Although the Settlement Administrator 24 will calculate and pay the standard Employee's Taxes and Required Withholding on the portion of the 25 Individual Settlement Amounts constituting wages on their behalf, Plaintiff and Class Participants 26 represent and understand that they shall be solely responsible for any and all tax obligation associated 27 with their respective Individual Settlement Amounts and Incentive Awards.

# 8.3. CALCULATION OF THE PAYMENTS FOR INDIVIDUAL MEMBERS OF THE PAGA SETTLEMENT CLASS

Each member of the PAGA Settlement Class shall be entitled to receive a portion of the PAGA Payment. The PAGA Payment shall consist of the penalties pursuant to PAGA that the Parties have agreed is a reasonable sum to be paid in settlement of the PAGA claims included in the Action, which is \$50,000.00. The PAGA Payment is to be approved by the Court pursuant to Labor Code section 2699 and is to be distributed as follows: seventy-five percent (75%) (i.e., \$37,500.00) to the LWDA and twenty-five percent (25%) (i.e., \$12,500.00) to the PAGA Settlement Class.

9 The portion of the PAGA Payment allocated to the PAGA Settlement Class shall be distributed 10 to the PAGA Settlement Class based on the pro rata number of pay periods worked by each particular 11 PAGA Settlement Class member during the PAGA Period as a proportion of all pay periods worked 12 by all PAGA Settlement Class members during the PAGA Period. Each member of the PAGA 13 Settlement Class, including Plaintiff, shall be responsible for the payment of the Employee's Taxes and 14 Required Withholding with respect to their share of the PAGA Payment and shall hold Defendant 15 harmless from any and all liability with regard thereto.

16 Defendant will provide the Settlement Administrator with any information reasonably 17 necessary to perform the calculation of number of pay periods worked for each PAGA Settlement Class 18 member, and any other reasonably required information the Settlement Administrator requests to 19 perform the calculations required under this Settlement Agreement. Defendant shall have no 20 responsibility for deciding the validity of the individual payment amounts allocated to each member of 21 the PAGA Settlement Class or any other payments made pursuant to this Settlement Agreement, shall 22 have no involvement in or responsibility for the determination or payment of Employee's Taxes and 23 Required Withholding, and shall have no liability for any errors made with respect to such Employee's 24 Taxes and Required Withholding.

The members of the PAGA Settlement Class shall be solely responsible for any and all tax obligation associated with their respective shares of the PAGA Payment.

8.4. TIME FOR PAYMENT OF ATTORNEY FEES AND EXPENSES
The Settlement Administrator shall distribute to Class Counsel any attorney fees and expenses
approved by the Court no later than fourteen (14) days after the Effective Date.
8.5. TIME FOR PAYMENT OF INCENTIVE AWARD
The Settlement Administrator shall distribute to Plaintiff the Incentive Award approved by the
Court no later than fourteen (14) days after the Effective Date.

# 8.6. TIME FOR PAYMENT OF PAGA PAYMENT TO THE LWDA

8 The Settlement Administrator shall distribute to the LWDA the portion of the PAGA Payment 9 due to it and approved by the Court no later than fourteen (14) days after the Effective Date.

# 8.7. TIME FOR PAYMENT OF TAXES AND REQUIRED WITHHOLDING AND INDIVIDUAL SETTLEMENT AMOUNTS

12 The Settlement Administrator shall make every effort to pay the Employee's Taxes and 13 Required Withholding associated with each Class Participant's Individual Settlement Amount and mail 14 the Individual Settlement Amount to each Class Participant, by first-class United States mail, to the 15 last-known address no later than fourteen (14) days after the Effective Date. If the Settlement Administrator is not able to do so within the time period set forth above, it shall so inform Class Counsel 16 17 and Defense Counsel and provide an approximate date by which the Employee's Taxes and Required 18 Withholding shall be paid and the Individual Settlement Amounts will be mailed. Under no 19 circumstances shall the Settlement Administrator distribute checks to Class Participants until all 20 Individual Settlement Amounts have been considered, calculated, and accounted for, and all of the 21 remaining monetary obligations have been calculated and accounted for.

Within two hundred ten (210) days of mailing the Individual Settlement Amounts to Class Participants, the Settlement Administrator shall file with the Court and provide to Class Counsel a declaration of payment. If any Class Participant is deceased, payment shall be made payable to the estate of that Class Member and delivered to the executor or administrator of that estate, unless the Settlement Administrator has received an affidavit or declaration pursuant to California Probate Code section 13101, in which case payment shall be made to the affiant(s) or declarant(s).

#### 8.8. NON-CASHED SETTLEMENT CHECKS

2 Any funds associated with checks that have not been cashed within one hundred eighty (180) 3 days, will become void and the Individual Settlement Amount associated with the uncashed check will be remitted pursuant to Code of Civil Procedure section 384 to the California State Controller for 4 5 deposit in the Unclaimed Property Fund in the name of the individual whose check was uncashed. The Parties agree that this disposition results in no "unpaid residue" within the meaning of California Civil 6 7 Procedure Code section 384, as the entire Net Settlement Amount will be paid out to Class Participants, 8 whether or not they all cash their Individual Settlement Amount checks. Therefore, Defendant shall not 9 be required to pay any interest on said amount. For the purposes of determining whether Defendant has 10 met their financial obligation to pay the Individual Settlement Payment, Defendant will be deemed to 11 have fulfilled its obligation upon the mailing of the check to the Class Member, regardless of whether 12 such Class Member subsequently negotiates the check.

# 8.9. DISPUTES REGARDING CLASS MEMBER WORKWEEKS DATA OR PAYMENT OF INDIVIDUAL SETTLEMENT SHARES

15 Class Member Workweeks and the corresponding Individual Settlement Amount shall be calculated using the employment and payroll records of Defendant, which presumptively shall be 16 17 deemed to be full, complete, and accurate for purposes of this Settlement Agreement. To overcome 18 that presumption, any Class Member objecting to the accuracy of the number of Workweeks or amount 19 of the Individual Settlement Amount must submit documentary evidence, such as pay stubs or other 20 written employment records, to the Settlement Administrator. Each Class Member may dispute the 21 number of Workweeks or their estimated Individual Settlement Amount contained on their Class 22 Notice ("Workweeks Dispute"). Any such Workweeks Dispute must be mailed or faxed to the 23 Settlement Administrator by the Class Member, postmarked or fax-stamped on or before the Response 24 Deadline. The Settlement Administrator shall immediately provide copies of all disputes to counsel for 25 Defendant, shall inform Class Counsel of the dispute without disclosing the identity of the Class 26 Member making the dispute, and shall immediately attempt to resolve all such disputes directly with 27 relevant Class Members with the assistance of Defendant, Defense Counsel, and Class Counsel. If the dispute cannot be resolved, it shall be submitted to the Settlement Administrator for its final, non-28

1 appealable decision. The Settlement Administrator shall use its best efforts to resolve all such disputes 2 prior to the Effective Date. If, however, a dispute arises or is not resolved until after the Settlement 3 Amount has been distributed, the initial calculation shall stand (as Defendant shall be under no obligation to pay any amounts in excess of the Gross Settlement Amount under this Settlement 4 5 Agreement).

# NULLIFICATION OF THIS SETTLEMENT AGREEMENT

#### 9.1. **NON-APPROVAL OF THIS SETTLEMENT AGREEMENT**

8 The Class Settlement and conditional class certification shall be considered null and void, and 9 neither the Class Settlement, conditional class certification, nor any of the related negotiations or 10 proceedings, shall be of any force or effect, and all Parties to the Class Settlement shall stand in the 11 same position, without prejudice, as if the Class Settlement had been neither entered into nor filed with 12 the Court, if any of the following occur: (a) the Court should for any reason fail to approve this 13 Settlement Agreement in the form agreed to by the Parties; (b) the Court should for any reason fail to 14 enter a judgment with prejudice of the Action, or (c) the approval of the Class Settlement and judgment 15 is reversed, modified, or declared or rendered void. Notwithstanding the foregoing, the Parties may attempt in good faith to cure any perceived defects in this Settlement Agreement to facilitate approval. 16

#### 9.2. PARTIES' RIGHTS TO VOID CLASS SETTLEMENT; ESCALATOR **PROVISION**

19 If 10% or more members of the Settlement Class timely submit Opt Out requests, Defendant 20 shall have the right (but not the obligation) to void the settlement described in this Settlement 21 Agreement.

22 At mediation, Defendant represented that there were approximately 453 Class Members that 23 worked a total of approximately 38,887 workweeks during the period of September 2, 2020 to the date 24 of mediation, September 24, 2024. If the number of workweeks worked by the Class Members between 25 during the Class Period exceeds 38,887 by more than 10% above, then the Gross Settlement Amount 26 shall be increased proportionately for each additional Workweek above the 10% buffer. If this 27 provision is triggered so as to increase the Gross Settlement Amount, the Parties agree that the portion 28 of the Gross Settlement Amount allocated to attorneys' fees will increase proportionally such that the total amount of attorneys' fees remains one-third of the Gross Settlement Amount after the upward
 adjustment required by this provision is implemented.

# 9.3. INVALIDATION

Invalidation of any material portion of this Settlement Agreement shall invalidate the Class
Settlement in its entirety, unless the Parties subsequently agree in writing that the remaining provisions
of the Class Settlement are to remain in full force and effect.

# 9.4. STAY ON APPEAL

8 If a timely appeal from the approval of the Class Settlement and judgment, the judgment shall 9 be stayed, and Defendant shall not be obligated to fund the Gross Settlement Amount or take any other 10 actions required by this Settlement Agreement until all appeal rights have been exhausted by operation 11 of law.

# **10.1. PRELIMINARY APPROVAL**

MOTIONS FOR COURT APPROVAL

As soon as practicable after execution of this Settlement Agreement, Class Counsel will submit this Settlement Agreement to the Court along with a Motion for Preliminary Approval of the Class Settlement. Each party shall cooperate to present the Class Settlement to the Court for preliminary approval in a timely fashion.

# **10.2. FINAL APPROVAL**

19 The Final Approval and Fairness Hearing shall be held before the Court. At the Final Approval 20 and Fairness Hearing, Plaintiff shall move the Court for the entry of the final order certifying the 21 Settlement Class for settlement purposes only and approving the Class Settlement as being fair, 22 reasonable, and adequate to the Class Participants within the meaning of California Rules of Court, 23 Rule 3.769, subdivisions (c), (d) and (e), and for the entry of a final judgment of the Action consistent 24 with the terms of the Class Settlement and rule 3.769, subdivision (h), of the California Rules of Court. 25 Class Counsel and Defense Counsel shall submit to the Court such pleadings and/or evidence as may be required for the Court's determination. 26

# 11. <u>RELEASES AND WAIVERS</u>

# 11.1. RELEASE OF CLAIMS BY THE SETTLEMENT CLASS

Upon the Effective Date, the Releasing Parties shall be deemed to each release the Released Parties, and each of them, of and from any and all Released Claims arising during the Class Period. It is the desire of the Parties and the Releasing Parties to fully, finally, and forever settle, compromise, and discharge the Released Claims. Each of the Releasing Parties, including each Class Participant and PAGA Settlement Class member, will be bound by the release of Released Claims as a result of the Class Settlement and to the terms of the final judgment and the satisfaction of such judgment.

9 Class Participants will be deemed to have acknowledged and agreed that their claims for wages 10 and/or penalties in the Action are disputed, and that their Individual Settlement Amount constitutes 11 payment of all sums allegedly due to them. Class Participants will be deemed to have acknowledged 12 and agreed that California Labor Code section 206.5 is not applicable to the Individual Settlement 13 Amount. That section provides in pertinent part as follows:

"An employer shall not require the execution of a release of a claim or right on account of wages due, or to become due, or made as an advance on wages to be earned, unless payment of those wages has been made."

# 11.2. RELEASE OF CLAIMS BY PLAINTIFF

19 Plaintiff, on behalf of himself and his dependents, heirs and assigns, beneficiaries, devisees, 20 legatees, executors, administrators, agents, trustees, conservators, guardians, personal representatives, 21 and successors-in-interest, whether individual, class, representative, legal, equitable, direct or indirect, 22 or any other type or in any other capacity, shall and does hereby forever release, discharge and agree 23 to hold harmless the Released Parties from any and all charges, complaints, claims, liabilities, 24 obligations, promises, agreements, controversies, damages, actions, causes of action, suits, rights, 25 demands, costs, losses, debts and expenses (including attorney fees and costs), known or unknown, at 26 law or in equity, which he may now have or may have after the signing of this Settlement Agreement, 27 arising out of or in any way connected with his employment with Defendant including, the Released 28 Claims, claims that were asserted or could have been asserted in the Complaint, and any and all transactions, occurrences, or matters between the Parties occurring prior to the date this Settlement Agreement is fully executed. This release is for any and all relief, no matter how denominated, including, but not limited to, back pay, front pay, vacation pay, bonuses, compensatory damages, tortious damages, liquidated damages, punitive damages, damages for pain and suffering, and attorney fees and costs, and Plaintiff hereby forever releases, discharges and agrees to hold harmless Defendant and the Released Parties from any and all claims for attorney fees and costs arising out of the matters released in this Settlement Agreement.

8 Plaintiff specifically acknowledges that he is aware of and familiar with the provisions of
9 California Civil Code section 1542, which provides as follows:

"A general release does not extend to claims that the creditor or releasing party does not know or suspect to exist in his or her favor at the time of executing the release and that, if known by him or her, would have materially affected his or her settlement with the debtor or released party."

- 15 Plaintiff, being aware of California Civil Code section 1542, hereby expressly waives and relinquishes all rights and benefits he may have under section 1542 as well as any other statutes or 16 17 common law principles of a similar effect. Plaintiff may hereafter discover facts in addition to or 18 different from those which he now knows or believes to be true with respect to the subject matter of all 19 the claims referenced herein, but agrees that, upon the Effective Date, Plaintiff shall and hereby does 20 fully, finally, and forever settle and release any and all claims against the Released Parties, known or 21 unknown, suspected or unsuspected, contingent or non-contingent, that were asserted or could have 22 been asserted upon any theory of law or equity without regard to the subsequent discovery of existence 23 of such different or additional facts.

# 11.3. CIRCULAR 230 DISCLAIMER

Each party to this Settlement Agreement (for purposes of this section, the "Acknowledging Party"; and each party to this Agreement other than the Acknowledging Party, an "Other Party") acknowledges and agrees that (1) no provision of this Settlement Agreement, and no written communication or disclosure between or among the parties or their attorneys and other advisers, is or

1 was intended to be, nor shall any such communication or disclosure constitute or be construed or be 2 relied upon as, tax advice within the meaning of United States Treasury Department Circular 230 (31 3 C.F.R. Part 10); (2) the Acknowledging Party (a) has relied exclusively upon her or its own 4 independent legal and tax advisers for advice (including tax advice) in connection with this Settlement 5 Agreement, (b) has not entered into this Settlement Agreement based upon the recommendation of any 6 other party or any attorney or advisor to any other party, and (c) is not entitled to rely upon any 7 communication or disclosure by any attorney or adviser to any other party to avoid any tax penalty that 8 may be imposed on the Acknowledging Party; and (3) no attorney or adviser to any other party has 9 imposed any limitation that protects the confidentiality of any such attorney's or adviser's tax strategies 10 (regardless of whether such limitation is legally binding) upon disclosure by the Acknowledging Party 11 of the tax treatment or tax structure of any transaction, including any transaction contemplated by this 12 Settlement Agreement.

### 12. <u>DUTIES OF THE PARTIES</u>

14

# 12.1. MUTUAL FULL COOPERATION

15 The Parties agree to cooperate fully with one another to accomplish and implement the terms of this Settlement Agreement. Such cooperation shall include, but not be limited to, execution of such 16 17 other documents and the taking of such other actions as may reasonably be necessary to fulfill the terms 18 of this Settlement Agreement. The Parties shall use their best efforts, including all efforts contemplated 19 by this Settlement Agreement and any other efforts that may become necessary by court order or 20 otherwise, to effectuate this Settlement Agreement and the terms set forth herein. As soon as practicable 21 after execution of this Settlement Agreement, Class Counsel, with the cooperation of Defendant and 22 Defense Counsel, shall take all necessary and reasonable steps to secure the Court's final approval of 23 this Settlement Agreement.

24

#### 12.2. DUTY TO SUPPORT AND DEFEND THE CLASS SETTLEMENT

The Parties agree to abide by all of the terms of this Settlement Agreement in good faith and to support the Class Settlement fully and to use their best efforts to defend this Class Settlement from any legal challenge, whether by appeal or collateral attack.

#### **12.3. DUTIES PRIOR TO COURT APPROVAL**

2 Class Counsel shall promptly submit this Settlement Agreement to the Court for preliminary 3 approval and determination by the Court as to its fairness, adequacy, and reasonableness. Promptly 4 upon execution of this Settlement Agreement, Class Counsel shall apply to the Court for the entry of a 5 preliminary order scheduling a hearing on the question of whether the proposed Class Settlement 6 should be approved as fair, reasonable, and adequate as to the Class Members, approving as to form 7 and content the proposed Class Notice and Share Form attached hereto as Exhibit 1 and Exhibit 2, 8 respectively, and directing the mailing of the Class Notice to Class Members. While Defendant can 9 reserve its right to object to facts or assertions made in the moving papers, Defense Counsel shall file 10 a notice of non-opposition to the granting of the motion for preliminary approval or join in the motion.

### MISCELLANEOUS PROVISIONS

#### 13.1. VOIDING THIS SETTLEMENT AGREEMENT

13 Pending Court approval and other than as provided herein, if any of the conditions set forth in 14 this Settlement Agreement are not met and satisfied, this Settlement Agreement may, at the option of 15 either Plaintiff or Defendant, be ineffective, void, and of no further force and effect, and may not be used or be admissible in any subsequent proceeding, either in this Court or in any other court or forum. 16 17 If either Party decides to void the Settlement Agreement, then the Settlement Agreement and 18 conditional class certification shall be considered void, and neither the Settlement Agreement, 19 conditional class certification, nor any of the related negotiations or proceedings, shall be of any force 20 or effect, and the Parties shall stand in the same position, without prejudice, as if this Settlement 21 Agreement had been neither entered into nor filed with the Court. Should any Party choose to void the 22 Class Settlement under this subsection, such Party shall be responsible for all Settlement Administrator 23 fees and costs actually incurred.

24

#### **13.2. DIFFERENT FACTS**

The Parties acknowledge that, except for matters expressly represented herein, the facts in relation to the dispute and all claims released by the terms of this Settlement Agreement may turn out to be different from the facts now known by each party and/or its counsel, or believed by such Party or counsel to be true, and each Party therefore expressly assumes the risk of the existence of different or presently unknown facts, and agrees that this Settlement Agreement shall be in all respects effective
 and binding despite such difference.

#### **13.3. NO PRIOR ASSIGNMENTS**

The Parties represent, covenant, and warrant that they have not directly or indirectly assigned, transferred, encumbered, or purported to assign, transfer, or encumber to any person or entity any portion of any liability, claim, demand, action, cause of action, or right herein released and discharged except as set forth herein.

#### 13.4. NON-ADMISSION

9 Nothing in this Settlement Agreement shall be construed as or deemed to be an admission by 10 any Party of any liability, culpability, negligence, or wrongdoing toward any other Party, or any other 11 person, and the Parties specifically disclaim any liability, culpability, negligence, or wrongdoing 12 toward each other or any other person. Each of the Parties has entered into this Settlement Agreement 13 with the intention to avoid further disputes and litigation with the attendant inconvenience, expenses, 14 and contingencies. Nothing herein shall constitute any admission by Defendant of wrongdoing or 15 liability, or of the truth of any factual allegations in the Action. Nothing herein shall constitute any admission by Defendant regarding the merits of the Claims in this Action, including but not limited to 16 17 claims for unpaid wages or violations under California or federal law. Nothing herein shall constitute 18 an admission by Defendant that the Action was properly brought as a class or representative action 19 other than for settlement purposes. To the contrary, Defendant has denied and continues to deny each 20 and every material factual allegation and all Claims. To this end, the Class Settlement of the Action, 21 the negotiation and execution of this Settlement Agreement, and all acts performed or documents 22 executed pursuant to or in furtherance of this Settlement Agreement or the Class Settlement are not, 23 shall not be deemed to be, and may not be used as, an admission or evidence of any wrongdoing or 24 liability on the part of Defendant or of the truth of any of the factual allegations in the Complaint in the 25 Action; and are not, shall not be deemed to be, and may not be used as, an admission or evidence of 26 any fault or omission on the part of Defendant in any civil, criminal, or administrative proceeding in 27 any court, administrative agency, or other tribunal.

#### 13.5. NON-EVIDENTIARY USE

Neither this Agreement nor any of its terms, nor any statements or conduct in the negotiation or drafting of it, shall be offered or used as evidence by Plaintiff, any Class Member (including any individual who requested to be excluded from the Settlement Class), Defendant, or its, her, his, or their respective counsel, in the Action, except as is reasonably necessary to effectuate the Settlement Agreement's purpose and terms. This Settlement Agreement may, however, be used by Defendant and the Released Parties to prove or defend against any claim released herein by any Class Member in any judicial, quasi-judicial, administrative, or governmental proceeding.

9

#### 13.6. MEDIA OR PRESS

Plaintiff and Defendant, and their respective counsel, recognize, accept, and agree that the Parties to this Settlement Agreement desire that the terms of this Settlement Agreement, the fact of the Class Settlement embodied in this Settlement Agreement, the disposition of the Action, the Action, and all matters relating to the litigation of the Action, including discovery proceedings therein, and evidence obtained during the course of the Action, shall not be discussed with or presented to the media or press.

#### 13.7. NON-RETALIATION

Defendant understands and acknowledges that it has a legal obligation to not retaliate against any Class Member who elects to participate in the Class Settlement or elects to Opt Out of the Class Settlement. Defendant will refer any inquiries regarding this Class Settlement to the Settlement Administrator or Class Counsel and will not discourage Class Members who are employees, directly or indirectly, from making claims, opting out, or objecting to the Class Settlement. None of the Parties, or their respective attorneys or agents, shall solicit or encourage any Class Members, directly or indirectly, to Opt Out of the Class Settlement.

#### **13.8. CONSTRUCTION**

The Parties agree that the terms and conditions of this Settlement Agreement are the result of lengthy, intensive, arms-length, non-collusive negotiations between the Parties and that this Settlement Agreement is not to be construed in favor of or against any party by reason of the extent to which any party or its counsel participated in the drafting of this Settlement Agreement. If any of the dates in this

Settlement Agreement fall on a weekend, bank or court holiday, the time to act shall be extended to the
 next business day.

# 13.9. GOVERNING LAW

This Settlement Agreement is intended to and shall be governed by the laws of the State of
California, without regard to conflict of law principles, in all respects, including execution,
interpretation, performance, and enforcement.

### **13.10. NOTICES**

8 Except for Class Member notices required to be made by the Settlement Administrator, all 9 notices or other communications required or permitted under this Settlement Agreement shall be in 10 writing and shall be sufficiently given if delivered in person to the party or their counsel by U.S. 11 certified mail, postage prepaid, e-mail, facsimile, or overnight delivery addressed to the address of the 12 party appearing in this Settlement Agreement.

13

# **13.11. CAPTIONS AND INTERPRETATIONS**

Section titles or captions contained herein are inserted as a matter of convenience and for reference only and in no way define, limit, extend, or describe the scope of this Settlement Agreement or any provision thereof.

# **13.12. MODIFICATION**

This Settlement Agreement may not be changed, altered, or modified, except in writing signed by the Parties or the Parties' counsel on their behalf. If preliminary or final approval of this Settlement Agreement has been granted by the Court, then any such amendments or modifications to this Settlement Agreement shall be approved by the Court. This Settlement Agreement may not be discharged except by performance in accordance with its terms or by a writing signed by the Parties.

### **13.13. INTEGRATION CLAUSE**

This Settlement Agreement contains the entire agreement between the Parties relating to the Class Settlement of the Action and the transactions contemplated thereby, and all prior or contemporaneous agreements, understandings, representations, and statements, whether oral or written, and whether by a party or such party's legal counsel, are hereby superseded. No rights under this Settlement Agreement may be waived except in writing as provided above.

# 13.14. SUCCESSORS AND ASSIGNS

This Settlement Agreement shall be binding on and inure to the benefit of the Parties and Class
Members (excluding only persons who timely Opt Out) and their respective present and former heirs,
trustees, executors, administrators, representatives, officers, directors, shareholders, agents, employees,
insurers, attorneys, accountants, auditors, advisors, consultants, pension plans, welfare benefit plans,
fiduciaries, parent companies, subsidiaries, affiliates, related companies, joint ventures, predecessors,
successors, and assigns.

# **13.15. CORPORATE SIGNATORIES**

Any person executing this Settlement Agreement or any such related document on behalf of a
corporate signatory or on behalf of a partnership hereby warrants and promises, for the benefit of all
Parties hereto, that such person has been duly authorized by such corporation or partnership to execute
this Settlement Agreement or any such related document.

# **13.16. EXECUTION IN COUNTERPARTS**

This Settlement Agreement shall become effective upon its execution by all of the undersigned.
The Parties may execute this Settlement Agreement in counterparts, and execution of counterparts shall
have the same force and effect as if all Settling Parties had signed the same instrument.

# 13.17. ATTORNEY FEES, COSTS, AND EXPENSES

Except as otherwise specifically provided for herein, each party shall bear her or its own attorney fees, costs, and expenses, taxable or otherwise, incurred by them in or arising out of the Action and shall not seek reimbursement thereof from any other party to this Settlement Agreement.

# **13.18. ACTION TO ENFORCE AGREEMENT**

In any suit or court action to enforce the terms of this Agreement, the prevailing party shall be entitled to recover her or its attorney fees and costs.

3 A proposed class action settlement agreement (the "Settlement") has been reached between: (1) Plaintiff Samuel Daldompre ("Plaintiff"), individually and in his representative capacity on behalf 4 5 of a group of prospective class members defined below, and as a private attorney general on behalf of the State of California; and (2) Defendant SDG Enterprises ("Defendant"). #### **DESCRIPTION OF THE LAWSUIT**

19 Plaintiff, individually and in his representative capacity on behalf of the Class Members, and 20 as a private attorney general on behalf of the State of California, is pursuing a lawsuit against Defendant 21 in the Superior Court of the State of California for the County of San Bernardino in the matter of 22 Samuel Daldompre v. SDG Enterprises, case number CIVSB2312325 (the "Action"). The Action 23 sought recovery for Defendant's alleged: (1) failure to pay minimum wage for all hours worked; 24 (2) failure to pay proper overtime wages; (3) failure to provide compliant rest periods and pay missed 25 rest break premiums; (4) failure to provide compliant meal periods and pay missed meal period 26 premiums; (5) failure to maintain accurate employment records; (6) failure to pay timely wages during 27 employment; (7) failure to pay all wages due and owing at separation; (8) failure to reimburse business 28 expenses; (9) failure to provide complete and accurate wage statements; and (10) deceptive, fraudulent,

or otherwise unlawful business practices based on the foregoing in violation of California's Unfair
 Competition Law.

3 Defendant denies all liability, denies all allegations in the Action, and has raised various 4 defenses to the claims. Defendant asserts that it fully complied with all applicable wage and hour laws, 5 and contends that civil penalties under PAGA are not warranted. Defendant also denies that the Action 6 is suitable for class certification. Defendant has entered into the Settlement solely for purposes of 7 resolving this dispute to avoid costly, disruptive, and time-consuming litigation and does not admit to 8 any wrongdoing or liability.

9 The Court has not ruled on the merits in the Action. By approving the Settlement and issuing 10 this notice, the Court is *not* suggesting which side would win or lose the case if it went to trial or 11 whether the claims are suitable for class certification. To avoid the additional expense, inconvenience, 12 and risk of continued litigation, however, Plaintiff and Defendant (the "Parties") have concluded that it is in their respective best interests and the interests of the Class Members to settle the Action on the 13 14 terms summarized in this notice. The Settlement was reached after Defendant provided extensive 15 information and documents to Plaintiff's counsel, and after lengthy arms-length non-collusive negotiations between the Parties, including mediation with an experienced and well-respected mediator 16 17 in California. In these negotiations, both sides recognized the substantial risk of the Court deciding 18 against them at trial and determined that the Settlement was a fair, reasonable, and adequate way to 19 resolve the disputed claims.

Plaintiff and Plaintiff's counsel—Jonathan Melmed, Laura Supanich, and Maria Burciaga of
Melmed Law Group P.C. ("Class Counsel")—support the Settlement. Among the reasons for support
are the defenses to liability potentially available to Defendant, the risk of denial of class certification,
the inherent risk of trial on the merits, and the delays and uncertainties associated with litigation.
Plaintiff and Class Counsel believe that the settlement described in this notice is fair, adequate,
reasonable, and in the best interests of Plaintiff and the Class Members.

Under the Settlement, the following settlement class will be certified under California law: *all individuals who are or were employed by Defendants as non-exempt employees in California during the Class Period.* The "Class Period" is defined as the period from September 2, 2020, through October

24, 2024. The Settlement provides for a gross settlement amount of \$669,966.00, a share of which is
 to be distributed to the Class Members based on the pro rata number of weeks worked by the Class
 Members during the Class Period as a proportion of all weeks worked by all Class Members. In
 exchange for their share of the settlement amount, all participating Class Members will be deemed to
 have released Defendant from liability on the terms described in this notice.

6 On [date of preliminary approval], the Court preliminarily approved the Settlement and 7 conditionally certified the settlement class. This notice is being sent to you because Defendant's records 8 indicate that you worked for Defendant during the Class Period and that you meet the definition 9 required to be treated as a Class Member.

# <u>IF YOU ARE STILL EMPLOYED BY DEFENDANT, THIS SETTLEMENT WILL</u> <u>NOT AFFECT YOUR EMPLOYMENT.</u>

California law strictly prohibits retaliation. Further, Defendant is prohibited by law from taking
 any adverse action against or otherwise target, retaliate, or discriminate against any Class Member
 because of the Class Member's participation or decision not to participate in the Settlement.

## TERMS OF THE SETTLEMENT

16Defendant has agreed to pay \$669,966.00 (the "Gross Settlement Amount") to resolve the17claims in the Action. The Parties agreed to the following payments from the Gross Settlement Amount:

181.Settlement Administration Costs. The Court has approved Apex Settlement19Administration to act as the "Settlement Administrator," who is sending this notice to20you and will perform many other duties relating to the Settlement. Under the Settlement,21up to \$30,000.00 will be paid from the Gross Settlement Amount to pay the Settlement22Administration Costs.

23 2. Attorneys' Fees and Expenses. Class Counsel have been prosecuting the Action on
24 behalf of the Class Members on a contingency fee basis (that is, without being paid any
25 money to date) and have been paying all litigation costs and expenses. To date, the
26 Parties have aggressively litigated many aspects of the case including investigation,
27 settlement efforts, and a full-day mediation session. The Court will determine the actual
28 amount awarded to Class Counsel as attorneys' fees, which will be paid from the Gross

Settlement Amount. Class Members are not personally responsible for any of Class Counsel's attorneys' fees or expenses. Class Counsel will ask for fees of one-third of the Gross Settlement Amount (i.e., \$223,322.00) as reasonable compensation for the work Class Counsel performed and will continue to perform in the Action. Class Counsel also will ask for reimbursement of up to \$25,000.00 for the costs Class Counsel incurred in connection with the Action.

- 3. Service Payment to Class Representative. Class Counsel will ask the Court to provide
  a service payment to Plaintiff in the amount of \$7,500.00 for Samuel Daldompre to
  compensate him for his efforts on behalf of the Class Members in the Action, including
  assisting in the investigation and consulting with Class Counsel and providing crucial
  documents to Class Counsel. Plaintiff also may receive a share of the Settlement as a
  Class Member.
- 13 4. **PAGA Payment.** The Parties have agreed on a reasonable sum to be paid in settlement of the PAGA claims included in the Action, which is \$50,000.00. The PAGA Payment 14 15 is to be approved by the Court pursuant to Labor Code section 2699 and is to be distributed as follows: seventy-five percent (75%) (i.e., \$37,500.00) to the LWDA and 16 twenty-five percent (25%) (i.e., \$12,500.00) to the individuals who come within the 17 definition of an "aggrieved employee" for the purposes of the Settlement (i.e., all 18 19 individuals who are or were employed by Defendants as non-exempt employees in 20 California during the PAGA Period). The "PAGA Period" is defined for these purposes to mean the period from May 31, 2022, through October 24, 2024. 21

After deducting the amounts above, the balance of the settlement amount will form the "Net
Settlement Amount" for distribution to the Class Members.

#### DISTRIBUTION OF THE SETTLEMENT TO THE CLASS MEMBERS

Each eligible Class Member who does not request exclusion from the Settlement will be deemed a "Class Participant" and will receive a share from the Net Settlement Amount which will be distributed pro rata based on the proportional number of weeks worked by each Class Member during the Class

Period (the "Individual Settlement Amount"). If any Class Member requests exclusion from the
 Settlement, his or her share will be distributed to the remaining Class Participants.

Twenty percent (20%) of each Individual Settlement Amount will constitute payment in the form of wages (and each Class Participant will be issued an IRS Form W-2 for such payment to him or her), and Eighty percent (80%) of each Individual Settlement Amount will constitute penalties and interest (and each Class Participant will be issued an IRS Form 1099 for such payment to him or her).

7 Defendant, or its proxies, shall take all usual and customary deductions from the Individual 8 Settlement Amount payments that are distributed as wages, including, but not limited to, state and 9 federal tax withholding, disability premiums, and unemployment insurance premiums. There will be 10 no deduction taken from the interest or penalty distribution—it will, however, be reported on IRS Form 11 1099 as income. Class Participants are responsible for the proper income tax treatment of their 12 Individual Settlement Amount. The Settlement Administrator, Defendant and its counsel, and Class 13 Counsel cannot provide tax advice. Accordingly, Class Members should consult with their tax advisors 14 concerning the tax consequences and treatment of payments they receive under the Settlement.

15 The workweeks you worked for Defendant during the Class Period will be calculated based on Defendant's records. If you feel that you were not credited with the correct number of workweeks 16 17 worked during the Class Period, you may submit evidence to the Settlement Administrator on or before 18 **[Response Deadline**] with documentation to establish the number of workweeks you claim to have 19 actually worked during the Class Period. Documentation sent to the Settlement Administrator will 20 not be returned or preserved, so do not send originals. The Parties and the Settlement Administrator 21 will promptly evaluate the evidence submitted and discuss in good faith how many workweeks should 22 be credited. The Settlement Administrator will make the final decision as to how many weeks are 23 credited and report the outcome to the Class Participant. If you are unsatisfied with the decision, you 24 may submit an objection, which is explained below.

- Settlement checks will be mailed to all Class Participants after the Court grants final approval
  of the Settlement and judgment is entered.

#### THE RELEASE OF CLAIMS

If the Court approves the Settlement, the Court will enter judgment and the Settlement will bind
all Class Participants. The Class Participants will then be barred from bringing any "Released Claims"
against the "Released Parties" as those terms are defined below.

5 The "Released Parties" are Defendant SDG Enterprises and all of Defendant's past and present 6 owners, subsidiaries, affiliates, shareholders, members, officers, directors, managers, employees, 7 attorneys, agents, predecessors, successors, assigns, representatives, and any and all other persons, 8 firms, companies, corporations, and partnerships which may have an interest in Defendant or could be 9 deemed a joint employer with Defendant under the law.

10 The "Released Claims" are those claims arising out of or related to the allegations set forth in 11 the operative complaint and/or PAGA notice to the California Labor and Workforce Development 12 Agency that arose during the Class Period and/or PAGA Period, including claims for: (1) failure to pay 13 minimum wage for all hours worked in violation of Labor Code sections 1194 and 1194.2, and the 14 applicable IWC Wage Order(s); (2) failure to pay proper overtime wages in violation of Labor Code 15 sections 510, 1197, and 1198, and the applicable IWC Wage Order(s); (3) failure to provide compliant rest periods and pay missed rest break premiums in violation of Labor Code section 226.7 and the 16 17 applicable IWC Wage Order(s); (4) failure to provide compliant meal periods and pay missed meal 18 period premiums in violation of Labor Code sections 226.7 and 512, and the applicable IWC Wage 19 Order(s); (5) failure to maintain accurate employment records in violation of Labor Code section 1174; 20 (6) failure to pay timely wages during employment in violation of Labor Code sections 204, 210; 21 (7) failure to pay all wages due and owing at separation in violation of Labor Code sections 201, 202, 22 and 203; (8) failure to reimburse business expenses in violation of Labor Code sections 2802 and 2804; 23 (9) failure to provide complete and accurate wage statements in violation of Labor Code sections 226 24 and 226.3; (10) deceptive, fraudulent, or otherwise unlawful business practices based on the foregoing 25 in violation of California's Unfair Competition Law (Bus. & Prof. Code, §§ 17200–17210); (11) statutory penalties based on the foregoing pursuant to PAGA (Lab. Code, §§ 2698-2699.6); and 26 (12) all claims for liquidated damages, penalties, interest, fees, costs based on the foregoing. No other 27

claims are released other than those claims specifically plead, or could have been asserted based on the
 allegations, in the operative complaint in the Action those claims that in the operative complaint.

3 The Settlement does *not* release Defendant or any person, party, or entity from claims, if any, 4 by Class Members for workers compensation, unemployment, or disability benefits of any nature. Nor 5 does it release any claims, actions, or causes of action which may be possessed by Class Members under state or federal discrimination statutes, including, without limitation, the California Fair 6 7 Employment and Housing Act (Gov. Code, §§ 12900–12996); the Unruh Civil Rights Act (Civ. Code, 8 § 51); the California Constitution; Title VII of the Civil Rights Act of 1964 (42 U.S.C. § 2000, et seq.); 9 the Americans with Disabilities Act (42 U.S.C. § 12101, et seq.); the Employee Retirement Income 10 Security Act of 1974 (29 U.S.C. § 1001 et seq.); and all of their implementing regulations and 11 interpretive guidelines.

Class Members who do not request exclusion from the Settlement will be deemed to have acknowledged and agreed that their claims for wages and penalties in the Action are disputed, and that the Settlement payments constitute payment of all sums allegedly due to them. Class Members will be deemed to have acknowledged and agreed that California Labor Code section 206.5 is not applicable to the Settlement payments. That section provides in pertinent part as follows:

"An employer shall not require the execution of a release of a claim or right on account of wages due, or to become due, or made as an advance on wages to be earned, unless payment of those wages has been made."

#### 6.1. DO NOTHING AND RECEIVE YOUR PORTION OF THE SETTLEMENT

If you do nothing, you will be automatically included as a Class Participant in the Settlement and will receive a settlement payment. You do *not* have to take any further action to receive your settlement payment. It is, however, the responsibility of all Class Members to ensure that the Settlement Administrator has your current address on file, or you may not receive important information or a settlement payment. The estimated amount of your settlement payment if you do nothing is included on the attached *Class Action Settlement Share Form*.

#### 6.2. REQUEST EXCLUSION FROM THE CLASS AND THE SETTLEMENT

If you do *not* wish to take part in the class action portion of the Settlement (the "Class Settlement"), you may exclude yourself (i.e., opt out of the Class Settlement) by sending the Settlement Administrator a letter or card postmarked no later than [Response Deadline] that specifically requests exclusion from the Class Settlement in this case. The request for exclusion must include your name, address, telephone number, and signature, and it should state:

Any person who submits a timely request for exclusion from the Class Settlement shall, upon receipt, no longer be a Class Member, shall be barred from participating in the Class Settlement, and shall receive no benefits from the class action portion of the Settlement. If you want confirmation of receipt of your request for exclusion, please send it by United States certified mail, return receipt requested, or contact the Settlement Administrator.

**Importantly**, Class Members who timely and validly request exclusion from the Class Settlement will *not* be excluded from their share of the PAGA Payment or from the release of the PAGA claims against Defendant. Requesting exclusion from the Class Settlement applies solely to the Class Members' entitlement to the class action portion of the Settlement and not their entitlement to the PAGA Payment. If you request exclusion from the Class Settlement you will still be entitled to your share, if any, of the PAGA Payment and shall still be part of the release of the PAGA claims.

#### **OBJECT TO THE SETTLEMENT**

2 You have the right to object to the terms of the Settlement if you do not request exclusion. If, 3 however, the Court rejects your objection, you will still be bound by the terms of the Settlement. If you 4 wish to object to the Settlement, or any portion of it, you may file with the Settlement Administrator 5 and the Court a written objection stating your name, address, telephone number, dates of employment with Defendant, the case name and number, each specific reason in support of your objection, and any 6 7 legal support for each objection. Objections in writing must be mailed to the Settlement Administrator—[Insert Settlement Administrator Address]—by no later than [Response Deadline] to 8 9 be considered. Objections that do not include all required information, or that are not timely 10 submitted, might not be considered by the court.

If you choose to object to the Settlement, you may also appear to speak at the final approval

in Department [Court Department] of the Superior Court of the State of California for the County of

above shall have waived any objection to the Settlement, whether by appeal or otherwise.

The Court may, at the time of the final approval and fairness hearing, have certain social distancing requirements or procedures for attendance at hearings. If you wish to object to the Settlement by speaking at the final approval and fairness hearing, you may contact Class Counsel, whose information is provided below, for more information about the Court's current social distancing procedures. You may also review the Court's website for the most current information.
