The Court has reviewed the Revised Timeline for Final Approval of Class Action Settlement submitted by the parties in this action, and hereby, revises the dates related to final approval of the class action settlement.

## IT IS HEREBY ORDERED THAT:

- 1. The Settlement Administrator will mail the Class Notice by first class U.S. mail to all Class Members on **June 3, 2025**.
- 2. Any Class Member may choose to be excluded from the Settlement by submitting a timely and valid written Request for Exclusion in conformity with the requirements set forth in the Class Notice, to the Settlement Administrator postmarked no later than **August 2**, **2025** (**August 16**, **2025** for Class Members whose Class Notice is re-mailed) after the Administrator mails Notice to Class Members and Aggrieved Employees. Any Class Member who chooses to opt out of, and be excluded from, the Settlement will not be entitled to an Individual Settlement payment, will not be bound by the Settlement, and will not have any right to object, appeal, or comment thereon. Class Members who have not submitted a timely and valid Request for Exclusion shall be bound by the Settlement Agreement and any final judgment based thereon.
  - 3. A Final Approval Hearing will be held before this Court on

in Department LA - 015 of the Los Angeles County Superior Court, Spring Street Courthouse located at 312 North Spring Street, Los Angeles California 90012, to determine all necessary matters concerning the Settlement, including: whether the proposed settlement of the Action on the terms and conditions provided for in the Settlement is fair, adequate, and reasonable and should be finally approved by the Court; whether a judgment, as provided in the Settlement, should be entered herein; whether the plan of allocation contained in the Settlement should be approved as fair, adequate, and reasonable to the Class Members; and determine whether to finally approve the requests for Attorneys' Fees and Costs, Class Representative Service Awards, Administration Costs, and allocation of the LWDA Payment.

1	4. Class Counsel shall file a motion for final approval of the Settlement and for
2	Attorneys' Fees and Costs, Class Representative Service Awards, and Administration Costs,
3	along with the appropriate declarations and supporting evidence by October 22, 2025, to be heard
4	at the Final approval Hearing. The deadline for Plaintiff to submit the settlement administrator's
5	declaration regarding the settlement administration process and any responses to objections is
6	October 22, 2025.
