Plaintiff David Lawson's ("Plaintiff") Motion to Modify the Court's October 16, 2024 Order Approving Class Notice came before this Court on August 7, 2025 at 2:00 p.m. before the Honorable Melissa R. McCormick in Department CX-105 of the Superior Court of California, in and for the County of Orange. The Court, having considered Plaintiff's Motion and all papers filed in support, no oppositions to the motion having been filed, and good cause appearing, HEREBY ORDERS THE **FOLLOWING:** 

- 1. The Court's October 16, 2024 Order Approving Class Notice (ROA 650) is modified as follows:
  - Notice to the Class Members shall be given in substantially the same manner as a. proposed in Plaintiff's Statement Regarding Class Notice (ROA 637), with the exception that, as an alternative to using the Class Members' Data to compile the Class List, Class Counsel may compile the Class List from (1) the class list produced by Defendant Executive Maintenance, Inc. on January 19, 2022; (2) the "Employee Job Agreement" forms produced by Defendant Executive Maintenance, Inc.; (3) the timesheets produced by Defendant Executive Maintenance, Inc.; (4) the wage statements produced by Defendant Executive Maintenance, Inc.; and (5) declarations obtained from Class Members.
  - Class Counsel is not required to send a proposed Class List compiled from this b. information to Defendants' counsel or to secure Defendants' counsel's approval before sending the Class List to the Administrator, but shall serve Defendants' counsel with a copy of the Class List at the same time Class Counsel sends the Class List to the Administrator.
- 2. All other aspects of the October 16, 2024 Order Approving Class Notice remain in full force and effect.
- 3. Therefore, the Court orders the Parties to comply with the Amended Class Notice Schedule, as follows:
