

1 **TO THE HONORABLE COURT, ALL PARTIES, AND THEIR ATTORNEYS OF**  
2 **RECORD:**

3 This Stipulation to Continue Final Approval Hearing and Case Management Conference is  
4 made and entered into by Plaintiff Jamal Ali (“Plaintiff”) and Defendant Diesel Direct West, LLC  
5 (“Defendant”), by and through their respective counsel of record, jointly stipulate and agree as  
6 follows:

7 **WHEREAS**, on August 28, 2025, the Court entered its Order granting Plaintiff’s Motion  
8 for Preliminary Approval and Class Action Settlement and set a hearing on Plaintiff’s Motion for  
9 Final Approval on January 29, 2026;

10 **WHEREAS**, as of the date of this Stipulation, the settlement administrator is in possession  
11 of the Class Action and PAGA Settlement Agreement and Class Notice, the Amendment to Class  
12 Action and PAGA Settlement Agreement and Class Notice, and the Court’s August 28, 2025 Order  
13 granting Plaintiff’s Motion for Preliminary Approval and Class Action Settlement;

14 **WHEREAS**, Defendant’s counsel is in the process of finalizing the class member data to  
15 provide to Apex Class Action for the notice mailing, which is estimated to be completed on or  
16 before January 15, 2026;

17 **WHEREAS**, the deadline for Class Members to respond will be 45 days after the date of  
18 mailing, with an additional 14 days for re-mailed notices, making the Response Deadline mid to  
19 late March 2026;

20 **WHEREAS**, additional time is needed to complete the notice mailing and receive the class  
21 members’ responses prior to the hearing on Plaintiff’s Motion for Final Approval of Class Action  
22 and PAGA Settlement;

23 **NOW THEREFORE**, the Parties hereby jointly stipulation and respectfully request the  
24 Court continue the January 29, 2026 hearing on Plaintiff’s Motion for Final Approval of Class  
25 Action and PAGA Settlement to April 13, 2026, or a date thereafter more convenient to the Court.




~~PROPOSED~~ ORDER
