**ORDER GRANTING PLAINTIFFS' UNOPPOSED MOTION TO MODIFY
PRELIMINARY APPROVAL ORDER TO PROVIDE NOTICE TO ADDITIONAL
CLASS MEMBERS AND TO
RESET FINAL APPROVAL HEARING AND RELATED DEADLINES**

AND NOW, this 29th day of December, 2025, upon consideration of Plaintiffs' Unopposed Motion to Approve Additional Notice and Reset Final Approval Hearing and Related Deadlines, the Court grants Plaintiffs' Motion and ORDERS as follows:

1. The Notice to additional Settlement Class Members is approved and shall be distributed by the Settlement Administrator;
2. The proposed postcard to Settlement Class Members who already received Notice is approved and shall be distributed by the Settlement Administrator;
3. The costs of additional Settlement Notice and Settlement Administration are preliminarily approved;
4. The following schedule and procedures for providing additional notice and extending the deadline for the final approval hearing and related deadlines are hereby approved:

Defendant to re-send CAFA Notice.	Within ten (10) days after the submission of the Addendum to Settlement Agreement to the Court.
Defendant to provide Settlement Administrator the contact information of each additional Settlement Class Member.	Within three (3) business days after the Court's order approving additional notice.
Settlement Administrator to mail and email (if email addresses are available) the Settlement Notice to additional Settlement Class Members.	Within five (5) days after receiving the contact information for the additional Settlement Class Members.
Settlement Administrator to mail and email (if email addresses are available) the Postcard to the 139 Settlement Class Members whom Notice was initially mailed.	Within five (5) days after receiving the contact information for the additional Settlement Class Members.
Defendant to electronically transfer the additional Settlement Amount of \$218,175.12 to the Settlement Administrator.	Within twenty-one (21) days after the Court's order approving Plaintiffs' Unopposed Motion to Modify Preliminary Approval Order to Provide Notice to Additional Class Members and to Reset Approval Hearing and Related Deadlines.
Deadline to postmark objections or requests for exclusion.	Forty-five (45) days after the Settlement Notices are initially mailed by the Settlement Administrator to the additional Settlement Class Members.
Plaintiffs' Motion for Approval of Attorneys' Fees and Costs.	Due fourteen (14) days prior to the updated Notice Deadline.
Settlement Administrator to provide to Class Counsel and Defendant's Counsel a total number of Settlement Class Members who filed timely and valid requests for exclusions from the Settlement.	Within five (5) business days after the updated Notice Deadline.
Plaintiffs' Motion for Final Approval of the Settlement Agreement.	Due fourteen (14) days prior to Final Approval Hearing Date.
Final Approval Hearing	April 8, 2026

5. The Final Approval Hearing is hereby set for April 8, 2026, at 11:00 AM, in Courtroom 1919, U.S. Courthouse, 219 S. Dearborn St., Suite 500, Chicago, Illinois, 60604.
