**FOURTH REVISED IMPLEMENTATION
SCHEDULE**

1 Plaintiffs Daniel Coyne, David Denton, and Sean Bollig, on behalf of themselves and those
 2 similarly situated (“Plaintiffs”), by and through their undersigned counsel of record, and Defendant
 3 Las Vegas Metropolitan Police Department (“LVMPD”), by and through its undersigned counsel of
 4 record, hereby stipulate to this Fourth Revised Implementation Schedule, as initially contemplated
 5 under the Stipulation and Order in Response to this Court’s Meet and Confer Order [Doc. 156].

6 In the course of jointly certifying that all members of the Settlement Class had been identified,
 7 the Parties discovered that the payroll data previously used to estimate Settlement Awards did not
 8 capture certain qualifying shifts worked by some Class Members. This discovery has delayed the
 9 preparation and mailing of the Updated Notices, as contemplated in subsection b. of the
 10 implementation schedule set forth below.

11 To accommodate the issuance of accurate Updated Notices, the Parties propose extending the
 12 deadline for the Claims Administrator to mail the Updated Notices as described herein to March 6,
 13 2026, and reducing the period for Class Members to postmark requests for exclusion or to file
 14 objections to forty-five (45) days from the date of mailing of the Updated Notice (as opposed to the
 15 sixty (60)-day period originally contemplated in the Stipulation and Order to Extend Notice Period
 16 and Reschedule Final Fairness Hearing, filed December 2, 2025).

17 The Parties submit that a forty-five (45)-day response period provides sufficient time for
 18 meaningful review and decision-making, while also allowing the settlement to proceed without
 19 unnecessary additional delay. The revised timeline balances the need to ensure proper notice and due
 20 process with the interest in efficiently moving the case toward final resolution. See e.g. *Torrise v.*
 21 *Tucson Elec. Power Co.*, 8 F.3d 1370, 1375 (9th Cir. 1993) (discussing approvingly, notice periods
 22 between 26 and 45 days).

23 The Parties further request corresponding extensions of the deadline to file the Joint Motion
 24 for Final Approval and to reschedule the Final Fairness Hearing consistent as indicated below.
