1 **[PROPOSED] JUDGMENT**

2 **TO ALL PARTIES AND THEIR ATTORNEYS OF RECORD:**

3 On May 12, 2025, the Court entered an Order which granted Plaintiff's Motion for
4 Preliminary Approval of Class Action, granted conditional class certification, approved the format
5 of the Class Notice, and set a Final Approval Hearing (the "Preliminary Approval Order"), thereby
6 preliminarily approving a settlement of the above-entitled action (the "Action") that was reached
7 between Plaintiffs Ixel Amairami Gonzalez, Leticia Romero, and Donovan Sheffield ("Plaintiffs")
8 and Defendants Golden State Supply, LLC and Advance Auto Parts ("Defendants") (together with
9 Plaintiff, the "Parties"), in accordance with the Parties' Joint Stipulation of Class Action Settlement
10 and Release (the "Settlement"). The Settlement was attached as **Exhibit A** to the Declaration of
11 Michael Elkin in Support of Plaintiffs' Motion for Preliminary Approval of Class Action Settlement
12 that was filed on December 19, 2024.

13 The Court has entered an Order granting final approval of the Parties' Settlement (the "Final
14 Approval Order"). The Court now has before it a [Proposed] Judgment.

15 The Court, having entered a Final Approval Order in this Action, and good cause appearing,

16 **HEREBY ADJUDGES AND DECREES AS FOLLOWS:**

17 1. The Court, for purposes of this Judgment, refers to all terms and definitions as set
18 forth in the Settlement.

19 2. The Court enters Judgment as follows: Plaintiffs, Class Counsel, PAGA Members,
20 the California Labor and Workforce Development Agency, and the Settlement Administrator shall
21 take nothing from Defendants except as expressly set forth in the Final Approval Order and according
22 to the terms of the Settlement.

23 3. The Parties shall bear their own respective attorneys' fees and costs, except as
24 otherwise provided for in the Settlement and approved by the Court.

25 4. This Judgment and the concurrently filed Final Approval Order are intended to be a
26 final disposition of the Action in its entirety and are intended to be immediately appealable.

27 5. Notwithstanding the finality of this Judgment, the Court shall have continuing
28 jurisdiction under Cal. Rules of Court, Rule 3.769(h) to enforce the terms of the Judgment.
