1 **TO THE COURT, THE PARTIES, AND THEIR RESPECTIVE COUNSEL OF RECORD:**

2 Plaintiffs David Eichner and Leslie Marie Quist Cantrelle (collectively, “Plaintiffs”) and
3 Defendant Star Holding, LLC dba Logistical Data Services (“Defendant”) (collectively with
4 Plaintiffs, the “Parties”) submit the following Joint Stipulation to Continue the Hearing Date for


1 **[PROPOSED] ORDER**
